

- e) No conditional quotations will be considered for competition.
- f) Defective items will have to be replaced at your own cost.
- g) This office reserves the right to postpone/and/or extend the date of receipt / opening of Quotations or to withdraw the same without assigning any reasons thereof.
- h) In the event of any of the above mentioned dates being subsequently declared as a holiday / closed day for this office, the tenders will be opened on the next working day at the scheduled time.
- i) In case of more bidders quoting same rate, the Competent Authority reserves full rights to select the vendor.
- j) A demand draft @ 2% of the quoted amount towards EMD (refundable) in favour of '**GOA SARVA SHIKSHA ABHIYAN SOCIETY**' should be

submitted in a separate sealed envelope along with your quotation in the office of Goa Samagra Shiksha.

- k) The successful tenderer will have to deposit a Security Deposit @ 10% of the total order value within 07 working days of the issue of the supply order. The security deposit should be furnished in the form of the Account Payee Demand Draft or Bank Guarantee drawn in favour of “**GOA SARVA SHIKSHA ABHIYAN SOCIETY**”. The security deposit should remain valid for a period of 90 days beyond the date of completion of the supply. The Security Deposit will not carry any interest.
- l) Bidders should furnish attested photocopy of PAN Card and Certificate of GST along with the quotations failing which quotations are liable to be rejected.
