

The quotations will be opened on the same day at 4:00 p.m.

- a) The supply should be made within 45 days from the date of receipt of the order directly in School premises within Goa (The list of schools shall be provided at the time of placing the order)
- b) The payment shall be made on receipt of the bill after supply of the material in good condition.
- c) The rates quoted should be inclusive of all taxes, if any.
- d) The product should be strictly as per the specifications.
- e) No conditional quotations will be considered for competition.
- f) Defective items will have to be replaced at your own cost.
- g) This office reserves the right to postpone/and/or extend the date of receipt / opening of Quotations or to withdraw the same without assigning any reasons thereof.
- h) In the event of any of the above mentioned dates being subsequently declared as a holiday / closed day for this office, the tenders will be opened on the next working day at the scheduled time.

- i) In case of more bidders quoting same rate, the Competent Authority reserves full rights to select the vendor.
